CAMERON PARISH POLICE JURY

APRIL 4, 2019

The Cameron Parish Police Jury met in regular session on Thursday, April 4, 2019, in the Cameron Parish West Annex Board Room in the Village of Cameron, Louisiana at 2:00 o'clock P.M. The following members were present: Mr. Davy Doxey, Mr. Kirk Quinn, Mr. Joe Dupont, Mr. Darryl Farque, Mr. Terry Beard, Mr. Magnus McGee, Mr. Anthony Hicks, and Mr. Lawrence Faulk. There were no members absent.

There was no Public Comment on the agenda items.

It was moved by Mr. Quinn, seconded by Mr. McGee and carried, that the reading of the minutes shall be dispensed with and approved.

It was moved by Mr. Quinn, seconded by Mr. Faulk and carried, that the board hereby approves to add the following item to the agenda: (Item 20) President Authority to sign contract with TranSystems, Cameron Ferry BUILD Grant Consultant. (Item 21) Authority to enter contract with Engineering Firm for Road Overlay Project.

It was moved by Mr. Quinn, seconded by Mr. Faulk and carried, that the application for the following drilling and pipeline permit be the same and hereby approved with the stipulations set forth by the respective Gravity Drainage Districts:

a. Harvest Midstream - Grand Chenier, Deep Lake, Lat 29 41 26.42, Long -92 40 37.40, (proposed installation of approx. 8,606 linear feet of 6-inch pipeline from an existing facility to an existing pipeline), Cameron Parish, LA. (190407)

It was moved by Mr. Faulk, seconded by Mr. Hicks and carried, that the applications for the following permits be and the same are hereby approved with the stipulations set forth by the respective Gravity Drainage Districts:

- a. Entergy Louisiana, LLC Sabine River to Mud Lake, T12S-R13W, (proposed access for Mud Lake T-Line maintenance of existing structures (electric lines towers) from Sabine River along Intracoastal Waterway to Mud Lake), Cameron Parish, LA. (190401)
- b. Louisiana Department of Wildlife & Fisheries Grand Chenier, Rockefeller Refuge, Section 31, T15S-R3W, (proposed refurbishment to an existing levee 17,915 linear ft, approx. 49,764 cy of borrow material from drainage lateral to be placed on levee), Cameron Parish, LA. (190402)
- c. Rosco Steven Gore Sr. Hackberry, Amoco Rd., Section 23, T12S-R10W, (proposed installation of 300 ft. x 10 ft. driveway for access to backside of property), Cameron Parish, LA. (190403)

- d. Gravity Drainage District No. 4 Oak Grove Area, Section 32, T14S-R7W, Section 3, T15S-R7W, (proposed restoration of Labove Bayou by replacing (2) water control structures having increased capacity to allow for proper evacuation of excess storm water runoff into Mermentau River and the control of excess tidal salinities), Cameron Parish, LA. (190404)
- e. <u>Venture Global Calcasieu Pass LNG</u> Creole, Grand Chenier, Sections 20 & 35, T14S-R7W, Section 5, T15S-R6W, (proposed (3) geotechnical borings and site surveys to support a future pipeline), Cameron Parish, LA. (190405)
- f. Sawbones Land & Timber Co. LP Hackberry, Sam Breaux Rd, Section 36, T12S, R10W, (proposed after-the-fact coastal use permit application for unauthorized activities that includes removing debris that consist of fish camp build in 1983 destroyed by hurricane and leveling the ground surface in preparation of building a new camp, plant trees and grass to stabilize the soil; E2015114), Cameron Parish, LA. (190406)

It was moved by Mr. Doxey, seconded by Mr. Faulk and carried the board does hereby reappoint Tammy Peshoff to the Fire Protection District No. One Board.

It was moved by Mr. Beard, seconded by Mr. McGee and carried the board does hereby reappoint Michael Semien to the Gravity Drainage District No. Four Board.

It was moved by Mr. Doxey, seconded by Mr. Faulk and carried the board does hereby accept the resignation of Bethany Vincent from the Recreation District No. Seven Board, authorizes, empowers, and directs the secretary to send a letter of appreciation to Ms. Vincent for her service to the board and tables the appointment for 30 days.

It was moved by Mr. McGee, seconded by Mr. Faulk and carried the board does hereby reappoint Nat Griffith to the Mosquito Abatement Control Board. Mr. Kirk Quinn recused himself from voting.

It was moved by Mr. McGee, seconded by Mr. Faulk and carried the board does hereby reappoint Wendy Harrington to the Fire District No. Ten Civil Service Board.

NOW, THEREFORE, I, Joe Dupont, President of the Cameron Parish Police Jury, Cameron Parish, Louisiana, do hereby proclaim the month of April 2019, as

FAIR HOUSING MONTH, in Cameron Parish, Louisiana and do hereby encourage all citizens to abide by the letter and spirit of the Fair Housing Law, and ask the citizens of Cameron Parish to join in reaffirming the obligation and commitment to fair housing opportunities for all.
