CAMERON PARISH POLICE JURY

JUNE 11, 2021

The Cameron Parish Police Jury met in regular session on Friday, June 11, 2021, in the Cameron Parish West Annex Board Room in the Village of Cameron, Louisiana at 2:00 o'clock P.M. The following members were present: Mr. Scott Trahan, Mr. Thomas McDaniel, Mr. Joe Dupont, Mr. Magnus McGee, Mr. Curtis Fountain, Mr. Kirk Quinn, Mr. Lawrence Faulk, and Mr. McKinley Guidry. No members were absent.

There was no Public Comment on the agenda items.

It was moved by Mr. McGee, seconded by Mr. Quinn and carried, that the reading of the minutes shall be dispensed with and approved.

RESOLUTION NO. 1141

PARISH OF CAMERON
STATE OF LOUISIANA

WHEREAS, Hurricane Laura made landfall near Cameron, Louisiana around 2:00 AM EDT on August 27, 2020, in the U.S. state of Louisiana. The storm came ashore causing significant damage to Jeff Davis Electrical Cooperative's (JDEC) electric transmission and distribution system serving southwestern Louisiana. Southwestern Louisiana was the hard-hit region, particularly Calcasieu and Cameron parishes; and

WHEREAS, JDEC is an electric cooperative founded shortly after passage of the REA Act of 1936 that made loan funds available to any company, public body, or private cooperative interested in extending service to rural areas. Currently, JDEC has a service territory covering portions of Allen, Calcasieu, Cameron, Jeff Davis, and Vermillion parishes. It supplies 60% of its total power load to commercial customers, including liquid natural gas facilities for onshoring of LNG; and

WHEREAS, on August 23, 2020, FEMA Region VI mission assigned the Department of Energy ESF #12 response team to provide situational awareness with respect to Laura's impacts to the energy infrastructure and made the following recommendations: Construct a **More Resilient & Redundant Transmission Line**. Replacing the existing system with hardened infrastructure, improved resiliency, and built-in redundancy to reduce down time and better protect from service interruptions. This will include a sequenced series of projects designed to mitigate susceptibility to physical damage, support anticipated load, increase resiliency of the coastal circuits, and allow for quicker restoration of power; and

WHEREAS, A 230 Loop will allow JDEC to support all of Cameron Parish from either the Hackberry or Lake Charles side of the Calcasieu Ship Channel, increase load handling capability and resilience simultaneously. Also, this would proactively address the projected load growth for critical infrastructure along the Cameron shoreline area. Additional recommendations include relocating the line closer to the highway, to allow for substantially reduce reconstruction cost and time and improve access for repair and maintenance in the future and elevating the substations.

NOW THEREFORE BE IT RESOLVED, by the governing authority of Cameron Parish, State of Louisiana, that Cameron

Parish hereby strongly urges the Southwest Louisiana legislative delegation to support all efforts of JDEC and FEMA throughout the recovery.
