**AGREEMENT OF TEMPORARY CONSTRUCTION BUILDING PERMIT**  
**FOR OPERATION OF BUSINESS**

This agreement is entered into by and between the Cameron Parish Police Jury and \_\_\_\_\_, authorizing a temporary construction permit to operate business on a temporary basis (6-month) during construction while working to bring the structure into compliance with the Cameron Parish Flood Damage Prevention Ordinance and Building Codes and Permits.

The Owner/Applicant and the Cameron Parish Police Jury hereby agree that the owner and/or applicant will be and/is hereby issued a temporary construction permit, subject to the following conditions and terms.

1. The temporary construction permit will be valid for a term up to six (6) months from the date of this agreement.
2. The temporary construction permit will authorize the operation of business, during construction phase purposes only.
3. The operation of business of this agreement is temporary and must be actively pursuing construction work to bring the structure into compliance.
4. At the expiration of the six (6) month term set forth in paragraph 1 the business/structure referred to in paragraph 2 must be in full compliance or subsequent renewals of this temporary permit will be available at the discretion of the Cameron Parish Permit Department upon building inspection provided that owner/applicant has made continued progress and/or written documentation of reasons why the temporary business must remain in operation.
