II. GENERAL CONDITIONS:

1. The building will NOT be rented to anyone under 21 years of age.
2. The Cameron Parish Police Jury shall NOT be responsible for any injury to any persons attending a function at the Cameron Multi-Purpose building per the attached Use Policy.
3. Any damages to either the building or surrounding area not reported to the Cameron Parish Police Jury Administration office upon arrival shall be the responsibility of the signed user of the Cameron Multi-Purpose Rental Agreement.
4. A copy of the liability insurance must be sent to Cameron Parish Policy Jury Administration Office two weeks before the date of the function.
5. Barbeque Pits and Burners are not allowed on the slab underneath the building. Crawfish/Shrimp/Crab tails and/or scraps are to be placed in a trash bag and put in the trash bins provided.
6. A "No Tolerance" policy will be followed at the facility.
7. The use of vulgar language and profanity will not be tolerated on premises. Noise will be kept to a minimum.
8. All rules and regulations posted in the building will be followed as well as the attached Use Policy.
9. No one shall tape, staple, nail or otherwise hang anything on the walls of the building.

III. CLEANING DEPOSIT:

A clean-up fee is required from all building applicants. This clean-up fee does not exempt you from the general clean up of the building and surrounding area, i.e. picking up trash, litter and depositing in available dumpsters. Below is a cleaning checklist.
